3. Overview of the information we collect

In accordance with POPIA, we may use your personal data to carry out our obligations arising from any contract with you, to assist with business requirements or where we have a right or duty to disclose the information in terms of law or industry codes.

3.1 Specific information we may hold

We may, for example, but not limited to; collect and use the following information about you:

4. Cookies and Web Beacons
